The main aim of the conference refers to decisions, plans, and actions that are undertaken to achieve specific health care goals within a society. Health policy can have a major impact on health and well-being, health care management encompasses the efforts involved in planning, directing, and coordinating nonclinical activities within health care systems, organizations, and networks.

Purpose of the Conference

The right to health, equity and solidarity are values that underpin health system transformations as goals to be achieved. But these changes and transformations are linked to specific interests because, although it may not seem so, health is one more field in which hegemonic projects are confronted, either because they respond to dominant interests or because they try to rescue lost values. Inequity in health is the expression of a particular socio-political and economic dynamic that has generated evident failures in terms of universality, equity and accessibility, which have repercussions on the efficacy/quality of health system management.

In recent years, the reform processes carried out by the State have had their origin both in the political-organizational logic that grants quasi-monopolies of thematic action to specialized ministerial areas in a discreet and narrow manner, and in the logic of disciplinary training of the experts and professionals who occupy them, giving way to reductionisms that "cut" their own action on complex problems into parallel, uncoordinated and even contradictory lines of action in their attribution of mono-causality to the problem on the public agenda. The management of this lack of comprehensiveness in the public view and action and of the tension between different thematic/disciplinary areas has repercussions on policies and strategies aimed at coordination between different areas whose functions and activities are linked in different ways to a multi-caused problem.

- The problems of the exercise of political and economic power in health as an expression of the quality of life.
- Elements for a proposal for Health Care Policy & Management based on the evaluation of past experiences.

In this sense, the fundamental objectives of our proposal are defined as actions aimed at improving the health and living conditions of all inhabitants; forming part of the social reform, constituting one of its pillars of development with justice, welfare and equity; contributing to the fight against poverty; prioritising the reduction of inequalities in health care and promoting shared responsibility; modernising the system to guarantee universal access, efficient and comprehensive services, improving their quality and extending coverage to currently unprotected groups; reducing the costs of health services; promoting a more efficient and comprehensive health care system; promoting the development of a more equitable health system; and improving the quality of health services; foster a more efficient and comprehensive health care system; promote the development of a more equitable health system; and improve the quality of health services; lead to the modernisation of the system to guarantee universal access, efficient and comprehensive services, improve their quality and extend coverage to currently unprotected groups; lower the costs of health services; promote private competition that complements the public effort and contributes to making the State's responsibility effective; stimulate social participation and coordination in health matters; foster intersectoriality.

This requires Primary Care as a central focus, a coherent and decentralised policy, a clear long-term vision of its structure and functioning, and an organisation of the system that ensures optimal use of resources.

Taking into consideration the above, we believe it is necessary to bring together a set of critically thinking actors to characterise the processes of health system transformation, including the following thematic areas
